## &Partners electronic notice, records and signature disclosure

Depending on the services or Accounts chosen, such documents delivered electronically could include but not be limited to Agreements such as Form CRS, From ADV2A, Form ADV2B, Regulation Best Interest Document, Bank Deposit Sweep Program Disclosures, Privacy Policy, etc.... Client hereby consents to such electronic delivery of all Agreements, understands they need access to certain systems to access these documents and consistent with this, affirms they have access to the internet, has a valid email address which has been provided to AP and has access to free PDF reader software, which may be required for some records.
